# 2024 Legislative Session Highlights

- Approx \$120 million dollars in opioid settlement fund appropriations over last two sessions
- Significant investments in Indian Country
- Capital funds for OTPs
- Additional Funding for Health Engagement Hubs
- Increased funding for naloxone; public health vending machines; syringe service program support

# Senate Bill 6099

Creates the Tribal Prevention Opioid Prevention and Treatment Account

20% of funds from the Opioid Abatement Settlement Account unless less than \$7.5 million – Starting July 1, 2025

RCW 43.79.483

#### **Other Tribal Funding Items**

- Tribal Opioid Summit \$750,000 to support SFY 24 and 25
- Tribal Prevention Campaign \$2,000,000
- Tribal Opioid Task Force \$480,000
- Icelandic Prevention Model \$1,500,000
- HCA, DOH, Commerce and GOIA are all hiring Tribal related positions



# **Tribal Capital Building Projects**

- 13 Facilities
- \$80,487,000
- Uses Include
  - Feasibility studies
  - Expansions/renovations
  - New buildings
- Includes both inpatient and outpatient facilities across behavioral health and substance use disorder (SUD)



# ESSB 6109

- Improving services and clarifying the child removal process in circumstances involving "high-potency synthetic opioids."
- \$479,000 Administrative Office of the Courts –Training for dependency professionals on danger of high potency synthetic opioids
- Dept of Children, Youth and Families
  - (\$972,000) 2 pilot sites to include third party safety participants and public health nurses in child protective services safety planning
  - (\$875,000) Support six legal liaison positions to work across the state with DCYF and the AGO to assist with child abuse and neglect cases
- \$384,000 Dept. of Health two full time staff to reach out to Latinx community for implementation of 6109



# Long Acting Injectable Buprenorphine

#### \$3,000,000 - 215 (126) Health Care Authority

- One-time basis, provide LAI buprenorphine to small providers that are not financially affiliated with a hospital
- Cover "costs and administration" for uninsured individuals that do not qualify for state/federal health insurance programs
- HCA to study alternative models that will ease access to LAI buprenorphine to the Office of Financial Management
- \$2,700,000 237 (7)(k)(i) Department of Corrections expand access to LAI bupe
- \$1,500,000 215 (136) Health Care Authority Street Medicine high intensity teams serving ppl with OUD, must be used to increase administration of LAI Bupe



## **Other Treatment Items of note**

- \$1,500,000 HCA Opioid Recovery Care Access (ORCA) Center program costs
- ♦ \$3,500,000 Opioid Recovery Care Access (ORCA) Center Capital Costs
- \$3,000,000 HCA Additional funding for Health Engagement Hubs
- \$2,000,000 HCA Rapid methadone induction pilot
- \$1,758,000 DOC MOUD for individuals who are incarcerated if on MOUD in jail or out of custody prior to transfer to Dept. of Correction
- ♦ \$4,250,000 Commerce OTP Capital grants to community providers



# Drug User Health

- \$10,250,000 222 (23) increased funding for naloxone purchasing and distribution
- \$745,000 222 (154)(a) naloxone and fentanyl test strips for high schools
- ♦\$133,000 222 (155) naloxone in public libraries
- \$1,500,000 222 (158) support for community harm reduction programs
- ♦ \$900,000 215 (142) naloxone vending machines



### Dept. of Health – ESSB 5950 Sec. 222 (157)

**\$**4,000,000

- Enhanced opioid and fentanyl data dashboards and data systems
- Must support use by state, local, public, and private partners in making strategic decisions
- Allows for a data collection, evaluation, and usage plan for the State Opioid and Overdose Response Plan




