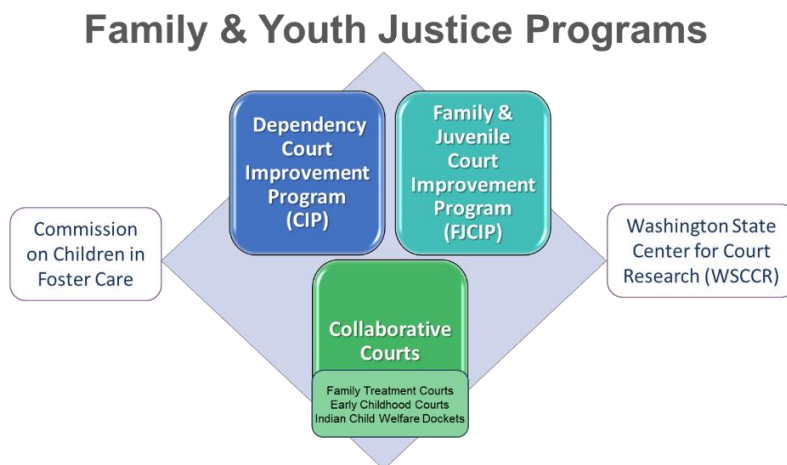
INTRODUCTION

Presiding over these cases is a significant responsibility that requires judicial officers to balance legal precision with the realities of family dynamics and child welfare.

By equipping you with necessary resources and knowledge, this guide aims to help you make informed, compassionate decisions that prioritize the best interests of children while balancing the rights and responsibilities of all parties.

Dependency Judicial Training Academy

Every spring, FYJP hosts a multi-day, virtual conference for judicial officers and court administrators who hear child dependency cases from Superior Courts, Tribal Courts, State Courts of Appeals, and the Washington State Supreme Court. Each year, the academy is co-designed with judicial officers from across the state.

The Judicial Community of Practice (JCoP) is a monthly, virtual peer-learning opportunity for judicial officers who hear child dependency cases. JCoP sessions are led by one of our expert [Jurists-in-Residence](#), who are retired judicial officers with years of experience hearing child dependency cases. iDecide

iDecide is an interactive, web-based tool designed to guide judicial officers through key inquiries that must be made during Shelter Care Hearings. This tool resulted from an intensive, cross-system collaborative project that included judicial officers, attorneys (for the state, parents & youth), DCYF staff, child advocates, community services providers, and individuals with lived child welfare experience as parents or youth. While iDecide aligns with current law, it does not replace the law. Instead, the iDecide tool helps judicial officers make informed decisions and navigate the complexities of dependency court proceedings. iDecide contains links to additional resources and trainings, including the Legal Standards Comparison Chart and interactive Harm of Removal Map.

Non-Offender Juvenile Benchbook

The Non-Offender Juvenile Benchbook outlines the state and federal statutory requirements for judicial officers hearing cases involving the welfare of children. The Benchbook contains topical sections as well as statutory and case law citations, including hyperlinks. The first iteration of the Benchbook was published in 2011. While select chapters have been updated since that time, many of the chapters are awaiting revision. FYJP is actively working with a legal advisory group to prioritize updates of the Benchbook in 2025.

FYJP supports peer learning from courts in the FJCIP Court Community and around the state. We encourage you to reach out to other dependency judicial officers and see how their courts function.

JUDICIAL WELLNESS

Dependency court judicial officers make tough decisions on a daily basis that have temporarily or permanently impacts on the lives of children, families and communities. As a result of this immense responsibility, judicial officers experience high rates of chronic stress which may lead or contribute to anxiety, depression, alcohol/substance abuse, and mental health issues. FYJP is here to help connect judicial officers to needed support and assistance.

Judicial Assistance Services Program (JASP)	JASP offers help from trained judicial officers, at no cost, and referrals to confidential professional help.	View
Jurist-in-Residence (JIR) Program	Jurists-in-Residence are retired, FYJP-contracted judges that can mentor judicial officers hearing dependency cases by providing guidance on navigating cases, court processes, docket management, and cross-system collaborative teams.	View
NCJFCJ Monday Morning Moments	Virtual webinars that promote judicial well-being and help develop strategies to mitigate the impact of stress that is inherent in the work.	View
